Demand drafts furnished as above shall be valid for a minimum period of 3 (three) months from the last date of publishing of bid. Bid Fee of **Rs.5,000.00 (Rupees five thousand)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.
