Eligible bidders shall participate in bidding only in online through website <https://tripuratenders.gov.in>. Bidders are allowed to bid 24x7 until the time of Bid closing, with option for Re-Submission, wherein only their latest submitted Bid would be considered for evaluation. The e-Procurement website will not allow any Bidder to attempt bidding, after the scheduled date and time. **Submission of bids physically is not permitted.**

Earnest Money and Bid Fee are to be drawn separately on State Bank of India or any other scheduled Bank guaranteed by the RBI, in the shape of "Deposit at call"/ "Demand Draft" in favour of the **Executive Engineer, Ambassa Division, PWD(R&B), Ambassa, Dhalai, Tripura.**

Demand drafts furnished as above shall be valid for a minimum period of **3 (three) months** from the last date of publishing of bid. Bid Fee of **Rs. 2500.00 (Rupees Two thousand five hundred)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.

The Bidders will have to upload the scan copy of the drawn "Demand Draft"/ "Deposit at call" (as a single PDF file of 100 dpi resolution), against the related Bid fee & Earnest money, along with the **Technical bid.**
