

Bidders are allowed to bid 24x7 until the time of Bid closing, with option for Re-Submission, wherein only their latest submitted Bid would be considered for evaluation. The e-Procurement website will not allow any Bidder to attempt bidding, after the scheduled date and time. **Submission of bids physically is not permitted.**

Earnest Money and Bid Fee are to be drawn separately on State Bank of India or any other scheduled Bank guaranteed by the RBI, in the shape of "**Deposit at call**" / "**Demand Draft**" in favour of the **Executive Engineer, Agartala Division No. I, PWD (R&B), Agartala, Tripura.**

Demand drafts furnished as above shall be valid for a minimum period of **6 (Six) months** from the last date of publishing of bid. Bid Fee of **Rs. 2,500.00 (Rupees Two thousand & five Hundred)** only, shall be accepted as "Deposit at call"/"Demand Draft" and is Non-Refundable.

The Bidders will have to upload the scan copy of the drawn "Demand Draft"/ "Deposit at call" (as a single PDF file of 100 dpi resolution), against the related Bid fee & Earnest money, along with the bid.
